## Meeting Minutes and Action Items

### Meeting Minutes

1. Michael Nolte opened the meeting with meeting minutes from May 3rd meeting. Jason Breithaupt made nomination to approve, Kim Ahne made second.
  2. Michael Nolte gave an overview of the meeting he and Kim Ahne had with Brian Charron, the superintendent of WCUSD#5.
  3. Michael Nolte also had a conversation with the City Engineer, Todd Striler who headed up a questionnaire that went out to a group of Waterloo Citizens, the top three top results that came out of that were that the Citizens would like to see Waterloo have a Community Center, a pool and a Rec Plex.
